Copy Machine

- 8 ½” x 11” – \$0.15/page
- Legal or ledger – \$0.20/page
- Double-sided – \$0.20/sheet
- Supplying own paper – \$0.10/page
- Color print – \$0.25/page

Printer

- 8 ½” x 11” – \$0.15/page
- Legal or ledger – \$0.20/page
- Double-sided – \$0.20/sheet
- Supplying own paper – \$0.10/page
- Color print – \$0.25/page
- Supplying own paper color print - \$0.15/page

Faxes

- Pages received – \$0.15/page
- Pages sent – \$1.00/page (cover sheet provided by Library free of charge and free to send)

Scans

- 8 ½” x 11 – \$0.50/page
- Color print – \$0.75/page

Laminates

- ID card – \$0.50/sheet
- 8 ½” x 11” – \$1.00/sheet
- 12” x 18” – \$2.00/large sheet

Disc Repair (see Disc Repair Policy)

- \$2.00 first attempt
- FREE second attempt (if necessary)
- \$1.00 third attempt (if necessary)

Research

- \$13.00/hour

- Actual replacement cost. An additional \$10.00 processing fee per item may be charged at the discretion of the Director

Replacement of Library Cards

- First lost card – FREE replacement
- Subsequent lost cards – \$5.00/card

Outside Patron Library Cards

For residents who reside outside the Library's taxing district, including Lind and Washtucna

- \$20.00/patron
- No charge for any child who attends school within the Lind, Ritzville, and Washtucna School Districts

Meeting Room

- Damage fees will be assessed if applicable

Computer Lab

- FREE (see Meeting Room Policy for additional information)
- Damage fees will be assessed if applicable
